**NOTICE IS HEREBY GIVEN,** that a public hearing of qualified voters of the Romulus Central School District, Seneca County,

Romulus, New York will be held in the Library of the Romulus Central School, 5705 Route 96, Romulus, Seneca County, New York on Tuesday, May 13, 2008, at 6:00 P.M. prevailing time for the purpose of discussion of the expenditure of funds and the budgeting thereof.

**AND FURTHER NOTICE IS HEREBY GIVEN,** that voting to fill two (2) vacancies on the Board of Education, and voting on the Budget, will be held on Tuesday, May 20, 2008. Voting by machine will be in the North Entrance Lobby of the Romulus Central School building, 5705 Route 96, Romulus, New York 14541, and polls will be open between the hours of 1:00 – 9:00 P.M. Only qualified voters will be permitted to vote. **PROOF OF RESIDENCY WILL BE REQUIRED.** 

AND NOTICE IS ALSO GIVEN, that petitions nominating candidates for the office of member of the Board of Education must be filed with the District Clerk no later than 5:00 P.M. on Monday, April 21, 2008. There are two (2) vacancies to be filled on the Board of Education; each vacancy is for a three (3) year term of office.

Each petition must be directed to the Board Clerk, must be signed by at least twenty-five (25) qualified voters of the District, must state the residence of each signer, and must state the name and address of the candidate.

**AND NOTICE IS ALSO GIVEN,** that a copy of the statement of the amount of money which will be required to fund the School District's budget for 2008-2009, exclusive of public monies, may be obtained by any resident of the District during business hours beginning May 6, 2008, except Saturday, Sunday, or holidays, at the District Clerk's Office.

**AND NOTICE IS ALSO GIVEN,** that applications for absentee ballots will be available after April 21, 2008 at the office of the District Clerk, Romulus Central School, 5705 Route 96, Romulus, New York 14541 during school business hours. Eligible District voters may use absentee ballots under the following conditions:

. That he/she is or will be on the day of the school election, a qualified voter of the school district in which he/she resides, that he/she is or will be on such date, over 18 years of age, a citizen of the United States and has or will have resided in the school district for 30 days next preceding such date.

. That he/she will be unable to appear to vote in person on the day of the school district election for which the absentee ballot is requested because he/she is or will be on such day (a) a patient in a hospital, or unable to appear personally at the polling place on such day because of illness or physical disability or (b) because his/her duties, occupation, business or studies will require him/her to be outside of the county or his/her residence on such day, or (c) because he/she will be on vacation outside the county of his/her residence on such day, or (d) absent from his/her voting residence because he/she is detained in jail awaiting action by grant jury or awaiting trial or is confined in prison after conviction for an offense other than a felony.

Completed applications must be received by the District Clerk at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the District Clerk no later than 5:00 P.M. prevailing time on Tuesday, May 20, 2008.
