SUPERINTENDENT'S REPORT:

2.1 Governor Paterson's proposed budget cuts
Mr. Hoose mentioned that the Suozzi Report to the Governor proposes
some cost saving measures for education; i.e., sharing services, District
mergers (no indication of forced mergers), and revision of State Aid
formulas. Mr. Hoose also reviewed four models of "When State Aid is
Frozen" and the "Impact of the Governor's Proposed Cuts", all relative
to local tax increases. He stated that we are at the point of "waiting for
a budget to be passed at both the BOCES and State level."

2.2RS WHEREAS the New York State Department of State, Division of Local Government Services has established a competitive statewide program due on January 14th, 2009 to fund planning initiatives that lead to shared services that reduce overall costs; and

WHEREAS, the County of Seneca, in concert with the Seneca Falls Central School District, the Romulus Central School District, the Town of Fayette, and the Town of Varick, proposes to apply for funding to conduct a Shared Maintenance Facility

Study to determine whether a single, centralized shared vehicle maintenance facility would reduce the overall maintenance costs to these communities and the County rather than maintaining separate facilities and services; and

WHEREAS, the County of Seneca would act as Lead Applicant with the Towns of Fayette and Varick and the Romulus Central and Seneca Falls Central School Districts as co-applicants supporting the project; and

WHEREAS, this grant, if awarded, would begin in Summer 2009, would provide \$29,000 in funds toward the Study, and would require a local cash match of \$3,223 (or 10%) to be provided by the County of Seneca and at no cost to the Towns or School Districts; and

WHEREAS, if awarded, all co-applicants will enter into an inter-municipal agreement for the purpose of conducting the Study, with this agreement listing in detail the duties and requirements of each partner;

NOW, THEREFORE, BE IT RESOLVED THAT the Romulus Central School District acknowledges the need to conduct the Shared Maintenance Facility Service Study, and fully supports the project as a co-applicant on the County of Seneca's application to the New York State Division of Local Government Services 2009 Local Government Efficiency Grant Program.
