#### **Proposition No. 2** –

RESOLVED THAT the Board of Education of the Romulus Central School District is hereby authorized to establish a Capital Reserve Fund to be used to finance, in whole or in part, the purchase of vehicles for student transportation, including all costs incidental to the acquisition thereof, in an ultimate amount not to exceed \$1,175,000, and to transfer into such fund the sum of \$163,975.08 (as of February 28, 2009) plus accrued interest, that is presently in the Bus Purchase Reserve Fund established by the voters on May 17, 2005, and to pay into such Reserve Fund annually thereafter such amounts as the Board may determine from current and future unappropriated fund balances. The Fund shall have a probable term of ten (10) years, and any withdrawal of funds for the purchase of vehicles for student transportation shall require the approval of the voters of the District.
