BE IT, FURTHER RESOLVED, THAT each of the following named individuals, hereinafter referred to as "Authorized Representative(s)" (Mark A. Socola, Phyllis Moore): are hereby authorized individually, without counter-signature or co-signature, to give instructions on behalf of the Organization for transactions in the Securities Account, and specifically to give written or oral instructions, by mail, telephone, telegraph or otherwise, to MLPF&S to buy, sell and transfer stocks, bonds, options, and/or other securities, commodities and commodity futures, whether for immediate or future delivery and to instruct the transfer of funds, including, but not limited to, the entire Securities Account, by wire, check or otherwise from the Securities Account of the Organization to or for the account of any other person, including the Authorized Representative giving the instruction; and

BE IT, FURTHER RESOLVED, THAT MLPF&S is authorized to accept instructions from any Authorized Representative with respect to: (a) registration of stocks, bonds,

Any such delivery of stocks, bonds, options and/or other securities, registered as directed by him or her, shall be deemed delivered to the Organization.

All confirmations, notices and demands upon the Organization may be delivered by MLPF&S orally or in writing by mail, telephone or telegraph to any such Authorized Representative; and

BE IT, FURTHER RESOLVED, THAT MLPF&S is authorized to receive from the Organization checks and drafts drawn upon the Organization's funds by any Authorized Representative or any employee of the Organization and apply the same to the credit of the Organization or its account; and

BE IT, FURTHER RESOLVED, THAT each Authorized Representative of the Organization is authorized to take any and all steps, do any and all things, and execute and deliver any and all documents in the name and on behalf of the Organization as may be necessary or appropriate to carry out the purposes of these Resolutions; and

BE IT, FURTHER RESOLVED, THAT all actions heretofore taken with respect to the matters authorized in these Resolutions be, and are, ratified, confirmed and approved; and
