AUDIT COMMITTEE REPORT

3.1 Review Internal Audit Report for 2010-11 as prepared by Raymond G. Preusser, CPA, P.C.

Mr. Boulware explained (at 6:10 p.m.) that the former Internal Auditor, Management Advisory Group, could no longer remain as such due to a conflict of interest on State Aid reports that must be submitted to NYS and that they also had been auditing. Thus, the accounting firm of Raymond G. Preusser, CPA, P.C. was recommended to the BOE Audit Committee on March 22, 2011 and approved at that time. The following is a review of their findings and recommendations.

Mr. Boulware stated that three high risk areas were discovered because they impact processes that are critical to the operation of the District: Area 1 – Budget Transfers;
