Professional Development

The PD plan has been submitted to SED and approval is still pending. Plans continue to be underway for the November 10th conference day. Leadership Council is planning and facilitating the day. Other PD is provided monthly at faculty meetings, with School Leadership Team members and other staff doing the presenting and facilitating. I believe I already shared this but each building has a monthly focus for Leverage Leadership visits whereby the expectations are set regarding instructional practice, PD is provided, and then the Principal monitors impact on teacher practice and student achievement through their LL visits. Brian shared an example of a rubric that he is using with staff. We know that this targeted focus, PD, and accountability will have an impact on our student results.

DCIP, SCEP, and LAP Plans

I traveled to Albany in September to learn more about the school review process at the middle school this year. I will be attending training again in January regarding the review process and will be leading an in-house review this year at the middle school. Reporting and review requirements for the DCIP and LAP have not been shared by SED yet but we will be prepared to meet those requirements.

<u>APPR</u>

After multiple phone calls with SED reviewers, the plan has been approved! Training will be provided for staff at faculty meetings during the month of October.

Other Notes

As we have talked about previously, we have a sub shortage at NRW, similar to most districts across the state. Principals are having to keep track of conference requests and have had to deny people's requests due to not having coverage. I just wanted to make you aware so that if you hear people are being denied PD it is due to our lack of coverage and staff attendance.

You saw June's summary of our elementary summer school program. We consider it to be a marked improvement from years past. Through talking with June & Jenn, and looking at some staff survey information, the following recommendations should be considered for this year's program:

- 1. Extend the day by 30 minutes, increasing Guided Reading time to one hour and 30 minutes.
- 2. Extend the session to 5 weeks, 4 days per week.
- 3. Include Kindergarten and 1st Grade

We will obviously talk more about this but I wanted to get it on your radar now.
