Student Achievement

SAP Goal 1: Proficiency on State Assessments

NRWE:

- NYS Math testing occurred this week. The test was administered over 2 days, rather than three this year.
 There were fewer items and students had unlimited time as with the ELA. Teachers have been using past test questions as practice so that students know what to expect. We also used released test questions on interim assessments. We saw students put forth great effort and they showed that they were using their strategies.
- Literacy Audit is continuing. Teachers have been interviewed and the auditor is visiting classrooms as well.

Middle School:

- NYS Math testing occurred this week. The test was administered over 2 days, rather than three this year. There were fewer items and students had unlimited time as with the ELA. Teachers have been using past test questions as practice so that students know what to expect. We also used released test questions on interim assessments. We saw students put forth great effort and they showed that they were using their strategies.
- The Middle School SLT has been working with the staff to gather input into the SCEP for the 18-19 school year. It is a good thing that we completed the review so early because we will have the SCEP mostly completed, if not all, prior to the end of June, which will help us with summer work and also planning for next year.

High School:

- o The HS is getting into Regents-prep mode. Teachers know the exact number of days until their exam and are working hard to ensure students are prepared for success.
- The High Schol SLT completed a reflection document, similar to what the middle school used to prepare for the focused review and that helped them to identify priorities for next year, which will be used to create their school improvement plan for next year.

SAP Goal 2: Mastery on State Assessments

Teachers in grades 3-8 have been targeting students that they feel can move from proficiency to mastery. We
have discussed individual students in great detail during meetings between the teacher, principal, and myself.
 We gave the teachers the charge that they must maintain students that have already reached mastery.

SAP Goal 3: Grade 2 Reading

We are anxiously awaiting the results of the Literacy Audit in K-2 so that we can plan for and make changes for
the upcoming school year, and provide some great PD opportunities over the summer. The Elementary SLT
completed a reflection document, similar to what the middle school used to prepare for the focused review and
that helped them to identify priorities for next year, with writing instruction being one of them.

SAP Goal 4: STEAM

We continue to work on developing STEAM programming at the K-8 level and are continuing to refine HS course
offerings so that they are further aligned to STEAM

Professional Development
