Superintendent's Dashboard Report

August 9, 2019

 This week the team met with SWBR and Campus to discuss all facets of the project. Negotiations between Campus and the contractors regarding the cancelation of work at the elementary school as well as the middle school redesign are ongoing. The contaminated soil has been removed from the middle school and test results are pending regarding the remaining soil.

I will also be meeting with James Evans to review a draft outline of a recovery plan regarding capital project issues.

The middle school roof repairs will soon begin and we anticipate a recommendation letter from Campus and SWBR by the end of next week. I have attached 4 change orders that require board approval Tuesday.

- The leach field reconstruction at NRWE has commenced. The contractor is onsite and is estimating the work will be concluded in 30 days or less depending on the weather
- We continue to work toward filling our vacant instructional positions. We are still
 interviewing for science, speech, music, family and consumer science, library
 media specialist elementary classroom, school psychologist, assistant principal
 and reading. I anticipate that some of the listed positions will be recommended
 during Tuesday's meeting.

Kellie Marciano was selected to serve as the next Director of Special Education and Pupil Personnel Services. She is currently serving as the interim in the same position and will be recommended for appointment on August 13. The special education department has been relocated from the district office to the elementary school so that staff have proximity to more appropriately support students and teachers. Also, Bridgette Barr started on July 1 as the Community Schools Administrator.

- I have attached my draft goals for your review and comment. This year I will be focusing on K-12 academics (Strategic Action Plan), capital project and the ES leach field.
- Several groups have expressed interest in purchasing FH. Details will be shared on Tuesday at 5:00 PM in executive session.

Goal 2:

Provide leadership and monitoring for \$35 million Capital Construction Project

Key Strategies:

- A. Work with the State Education Department, Regional Associate, District Superintendent, Board of Education, architect, financial adviser and construction manager and District staff in order to facilitate the completion of project under budget and on time.
- B. Facilitate regular meetings with appropriate stakeholders communicate and distribute project updates, timelines and financials to appropriate audiences; review monthly board reports prepared by the architect and construction manager

C. Attend professional development opportunities that will enhance capital project knowledge

Goal 3:

Continue to work with architect and engineer to diagnose and remediate NRWE School sanitary system

Key Strategies:

- A. Work with the State Education Department, District Superintendent, Board of Education, architect, financial adviser, construction manager and District staff in order to facilitate the remediation of the 2015 emergency sanitary project
- B. Develop a short-term plan to keep sanitary system operation for the 2018-19 school year
