Sun. - Joined up at HT picnic -
but parents followed me the whole
time

Mon. - Picked up the kids to go to the
park - went to park & Kelly said
she wanted to meet up there →

Sept.

Mon. 9/10/ Matthew asked if many could come to park by bike - Kelly said sure - but I informed her that she could come w/ us as long as she will let me pick up/drop off the kids if they ask

Tues. - Came home at 7:30p - read books to kids

Wed. - Packed up kids & went on boat to park & dinner.

Thurs. - Came home at 7:50

- Try to explain to Kelly that tomorrow was my day - & I should be able to have the kids - sounds like she's going back to work

- I'm not

- Friday - first time Kelly let Matthew & Bernadette ride with me when they asked. Went to DD & had breakfast together then she asked kids who they wanted to ride with today care.

- Sat. - Went to ALS walk then Mom's House w/ kids. Came home for kids to go to bed.

- Sunday - went to Church then Coffee Hour w/ Kelly & her parents. They stared and washed. Then went to my Dad's. Bernadette wake up

from Nap w/ fever - let went to Mom's & then to town to get meds. Kelly called & stated she needed to be involved. I gave her all information

9/17-9/21

Monday - Dad Matthew wanted me to take him to day care and pick him up. Kelly declined his request. After school I informed Kelly I was going to pick up Bernadette so she didn't stay more than an hour at daycare. I received

→ Tuesday - informed Kelly that I need to sweeten my day next week due to open house. Also emailed @ house w/ real estate agents. Met w/ real estate agent (her choice) to sell the home. She wouldn't tell her his name until I met him. No discussion afterwards.

→ Wed: - Picked kids up then hung out at home. Kelly came home @ 8:45, had dinner with us then ~~went home~~ - did not say when arrived back around 9:00pm

Thursday - stayed late at school to work on project.

→ Friday - Picked up Matthew @ 3:25p. Kelly was not around and she & I could not get a hold of her.

So Matthew & I went to the Red Creek Playground.

→ Sat. Kelly & kids left before me & didn't say where or what was going on. Came home for bedtime.

→ Sun. Picked kids ready for church. Couldn't find my keys so they left earlier. Met up after church - didn't say where she was going or what they were doing. Kelly got groceries very giant card.

9/23 cont.

- Sunday Emily Kelly arrived @ 7:30 and left them as she did water. While I was reading books Kelly went to do the laundry - I asked her not to touch my laundry. She ignored my request. She became violent and angry and aggressive. She threatened me, put me up a corner and allegedly started yelling "you pushed me I'm calling 911."

- Monday - Came home and she was at her parents. Came home @ 7:50p All Normal - I

~~Tuesday~~ - read the books to Matthew as per his request.

- Tuesday Picked up the kids and went home to meet realtor. Made dinner for them & Kelly. Then cleaned up, met realtor then took kids to B's & was home by 7:30p. Fed Matthew breakfast.

- Wed - took kids to Daycare. After school I tried calling Kelly to talk to the kids, no response.

Came home around 9pm.

- Thursday - morning fed Matthew breakfast then went to school. After school tried calling Kelly to talk to the kids - No answer. Went to her school to all of talk to the kids. Her mother would not tell me where they were.

9/27 Thurs. Cont. → Came into her school to talk to Kelly b/c she had open house (work). Her mother was there to watch the kids while Kelly "worked." I was never notified or called about this. I was asked to leave the building by her principal - and she called 911 to get me to leave but I was fully compliant. This all could have not happened if Kelly communicated this with me.

9/28 — Friday - Same morning - fixed the kids breakfast. Picked them up to Jan @ payment - She was fine. Pamela told me that Kelly was just going to pay for half - She never told me! Took the kids to ~~the~~ dinner w/ my mom & aunt then to watch 1/2 time show w/ cousins, moms for baths & then home.

9/29 → Kelly called my father looking for me. Sat. Left early in the morning to my mom's. Then B-day party after apple fest in the morning. Sunday - Church - ~~to~~ look @ houses then to my dad's to hang & watch football.

→ Mon. Took the kids - Kelly asked if she could take the kids in the morning. I declined.

10/1/12 Tuesday Mom slept. got home late. Missed Matthew's Dr. Appointment @ Dr. Davis
Missed Dr. App. → did not know @ appointment. free from the 4yr. old physical → ahead

10/2

Same morning - Kelly asked if I was going into work today - fed the kids breakfast.

10/3 Had kids & took them to school my school to watch the sporting events.

10/4 Stayed @ school to watch sporting events since students requested it.

10/5 Picked up Matthew from daycare

→ ~~10/5~~ Received letter from Kelly (email) regarding the concert on Sunday & other issues & responded only about concert.

10/6 Went to Greece area to help my dad

@ No response from Kelly. She texted me regarding Matthew's sweatshirt which I don't have.

10/7 No response from Kelly yet regarding concert this afternoon. Kids wake up & wanted to be with me today - Kelly said "no"

→ Matthew wanted me to get him dressed. She kept pushing him to get dressed he ran around the house to get away from her. He ran into the bathroom and she cornered him, like she did to me. He was defenseless & she was aggressive, confrontational, bullying my son.

→ After church Kelly came home with her father & the kids.

10/7 Cand.

→ She was aggressive & very upset that I ~~do~~ put my wet clothes back in the dryer to finish drying. Her father told my son I was marking today when he asked what I was doing today. I told Matthew my plans and for chuck not to lie to my son.

→ Just received email from Kelly - WILL NOT Allow me to have the kids on Sunday for the Marine Band Concert.

10/2 - Kelly moved out of the house with out warning or explanation. She did leave me with bags that came from my family and some clothes from my family. Matthew should have never been thought this. He was mortified that everything was gone.

It was also my weekend with the kids - There are some items that were both of our.

10/14 decided to move out & vacate the home.

10/16 & 17 Meet with Gawa realtors
Hopefully she picked one out

10/18 Swim Class tonight. She ^{texted} called @ 5:30 4:54pm to let me know they wouldn't be going to swim class. She said that "Matthew doesn't want to" and that he's tired. Obligations are not in the agreement.

10/27 Tans was cloudy today. Kelly called me and TOLD me that Matthew was going to Randa's. I told her that I shouldn't be obligated to pay ~~since~~ if we are following the agreement - technically it's my day and the decision should be mine - not hers. My mom was also available to watch him today.

10/27 Kelly informed me that her attorney explained to her that she did not have to provide clothing & diapers for the children. That the support ~~is~~ was only for her when the children are with her.

10/28 - Emailed regarding health care plans from Red Creek. Waiting for response

10/30 - Requested to take the children since she had to work & had a "short" day. She said in a text that the kids need to stick to their ~~routine~~ routine - Emailed her regarding Halloween

~~10/30~~ - Her year and no Itinerary was sent out.

10/31 - Halloween - went to her house after McD's for dinner. Met up with her neighbor & their two young children. Was asked by her to come into her parents house. Was told by her mother to part in the lawn since it was Halloween.

11/1 - All Saints Day. Was notified that the kids will not be swimming due to Holy Day of Obligation. at 3:45 pm that day.

- Notified that Bernadette had a fever and they weren't going to church. I texted her back 6:50p asking to take Matthew to church. No Response

11/1 - Matthew called asking for me.

~~Nov~~ 11/2 - @ 6:14A - She said she was going to keep Bernadette home. Asked her if she wanted me to take Matthew to daycare. - No Reply.

11/2 - Texted her at Noon to see how B. was doing - Responded @ 4pm

11/4 - Notified of Bernadette's power & that she was taking her to the Dr's office in Webster = didn't really say which office.

11/5 - Emailed Thid some regarding the mortgage payments

11/7 - Received an email regarding the Bills for the house. Still want to communicate with me regarding the house or the children. Expressed how she's the "big person" in all of this. Still don't have anything from her regarding healthcare. Matthew asked me if tomorrow was my day & night.

12/2012

December - Holidays - Holiday Break
- Complained about schedule - Said that we should "restart" so she could get more days.
Didn't communicate at all regarding who has what day.

Jan. 2013 - Constantly asks for exactly everything back. Only provides me with 1 diaper for Bernadette. ~~of~~ The basic clothing for the children - pants, socks, underwear, diaper & t-shirt - Even in the winter ~~only~~ No hats or gloves or scarfs for the kids. ~~at~~

1/9/13 Told Bernadette as collateral
Was not going to give me Bernadette until
I gave her "her clothes" back or told her
when I would give her her clothes back

- ~~Dr~~ Does not respond to my emails regarding the days off from school.
If she does respond - she does not answer any of my questions. just tells me what will be happening

- ~~But~~ After picking up Bernadette one morning, Matthew explained that he will be going to the school his "mom goes to."
Kelly Never explained this to me.
