RESOLVED THAT the Board of Education of the Romulus Central School District, Seneca County, is hereby authorized and directed to establish a Capital Reserve Fund – Purchase of Buses for a sum of money not to exceed \$1,700,000 and a probable existence of ten (10) years, for the purchase of school buses used for transportation of District students. The source of funds shall be obtained from the liquidation of the current Bus Purchase Reserve Fund and the current and future unappropriated fund balances as directed by the Board of Education; and

BE IT, FURTHER, RESOLVED THAT the Board of Education of the Romulus Central School District authorizes the withdrawal from this Fund of money not to exceed one hundred and twenty thousand dollars (\$120,000) for the purchase of one (1) 66-passenger school bus during the 2013-14 school year.
