JOINT BOE MEETINGS SCHEDULED COMBINED BASEBALL TEAMS

2.1 Update

Mr. Hoose mentioned that he had sent a letter to Senators Nozzolio and Kolb regarding the inequity of State funding for education, reviewed the Governor's State Aid Proposal that was discussed in the Budget Committee Meeting, and announced that an "open" joint BOE meeting with the South Seneca CSD BOE will be held on February 6, 2012 at 7:00 p.m. in the South Seneca Auditorium. Merger consultants Silky and Pohl will be presenting the Merger Process, followed by a Question and Answer session.

Also addressed was the combining of the Modified, JV, and Varsity Basseball teams from RCS and South Seneca for the Spring 2012 season. Mr. Pane, Athletic Director, stated that maintenance of both District's fields will be "a wash" since they each will be prepared and used. As of this date, the student signup numbers for Modified are not known. Mr. Pane suggested that Varsity games be played at South Seneca, with the JV and Modified played at Romulus.

MARKETING TRIP TRANSPORTATION REVISED

2.2RS WHEREAS the RCS Foundation Grant funded Marketing Trip on May 3-4, 2012 to Buffalo, NY, was originally approved on October 25, 2011, with a revision to increase the Grant money approved on January 17, 2012; and

WHEREAS this revision results in a need to change transportation for additional students on this trip; and

WHEREAS the NYS Department of Transportation (DOT) regulations stipulate that "a volunteer school buş driver shall mean every person who occasionally transports passengers to and from extra-curricular activities sponsored by a school or religious organization fewer than 30 days per calendar year and where such driving is unpaid and incidental to any terms or contract of hire ... and a volunteer may be a teacher, coach, minister, or parent, etc. ..."; and

WHEREAS, Rebecca Elder, Transportation Director for RCS, has cleared, through DMV, the personal driving abstracts for Nancy Munn and Jeffery Felice, Marketing Club Advisors, to be "volunteer drivers" of the 7-passenger School Van;

BE IT, THEREFORE RESOLVED, THAT Mrs. Munn and Mr. Felice be approved as volunteer drivers of the RCS van for May 3-4, 2012 only for the purpose of transporting five (5) students and two (2) Advisors to Buffalo, NY, at no cost to the District.

COMBINED BASEBALL TEAM RESOLUTION

2.3RS WHEREAS the Romulus Central School District and South Seneca Central School District Athletic Directors, Superintendents, and several BOE members met to ascertain the advantages of COMBINING sports teams; and

WHEREAS the Romulus Central School District and the South Seneca Central School District have agreed on terms for combining certain sports;

BE IT, THEREFORE RESOLVED THAT upon the recommendation of Michael J. Hoose, Superintendent, the Romulus Central School Board of Education approves the COMBINED TEAMS of Modified, Junior Varsity and Varsity Baseball for the 2012 Spring season; and

BE IT, FURTHER RESOLVED THAT the South Seneca Central School District will be the host school with the South Seneca CSD Coaches' salary schedule and Coaches' handbook being followed; and

BE IT, FURTHER RESOLVED THAT the athletes from each District will follow their own school's Code of Conduct and Eligibility Policy; and

BE IT, FURTHER RESOLVED THAT all of the costs associated with the Modified, Junior Varsity and Varsity Baseball program for the 2012 Spring season (such as supplies, field maintenance, officials, salaries and transportation) will be equally shared between the Romulus Central School District and the South Seneca Central School District; and

BE IT, FURTHER RESOLVED THAT transportation will be provided for Romulus athletes to practices and home games that will be held at the South Seneca Central School District.
