### ATHLETIC DIRECTOR'S REPORT:

## 2012-13 COMBINED SPORTS UNDER REVIEW

13.1 Update

Mr. Pane discussed the recommended combined sports possibilities for the 2012-13 school year with South Seneca CSD. He did state that the recommendations are based on participation, possible savings, and program sustainability. The sports being considered are Fall Volleyball, Boys' Soccer, Football and Golf; Winter sports are Indoor Track, Co-Ed Bowling, Wrestling, Cheerleading and Boys' Basketball; Spring sports are Baseball and Track.

## SUPERINTENDENT'S REPORT

2.1 Update

Mr. Hoose mentioned that he had met with the Faculty on the March 15, 2012 Teacher Conference Day to update them on the forthcoming Capital Project, APPR, the Merger process, the 2012-13 school Budget, and other general information.

Additionally, he updated the BOE members on the current 4<sup>th</sup> Grade structure and changes that have been made so far this school year relative to the ELA Curriculum. Mr. Hoose also indicated some considerations for the 2012-13 school year for 4-6 Grades. Currently, Administrators and teachers are in the "middle of determining staffing for next year, and that results on State tests for Grades 3-8 will give additional data needed to make any other changes," as well as teacher feedback.

#### SENIOR TRIP AUTHORIZED

He also mentioned that the Seneca Falls CSD Transportation Dept. is upgrading their camera systems used on buses and will be donating eight cameras to RCS for their upgrade. The only cost will be in the removal from the SFCSD buses and the installation of them in RCS buses.

# BLUE MILLION INSURANCE TO BE DISCONTINUED

Mr. Boulware stated that both the CSEA and the RFA Collective Bargaining Units have agreed to offer the Healthy Blue High Deductible Insurance Plan and to discontinue the Blue Million Insurance Plan, effective July 1, 2012.

Petitions to nominate a School Board member may be obtained from the District Clerk's Office at Romulus Central School, 5705 Route 96, Romulus, New York 14541, Monday through Friday, exclusive of legal holidays, between the hours of 8:00 a.m. and 4:00 p.m. Each petition must be directed to the Board Clerk, must be signed by at least twenty-five (25) qualified voters of the District, must state the name and residence of each signer, and the name and residence of the candidate.

AND NOTICE IS ALSO GIVEN, that a copy of the statement of the amount of money which will be required to fund the School District's budget for 2012-2013, exclusive of public monies, may be obtained by any resident of the District during business hours beginning May 1, 2012, except Saturday, Sunday, or holidays, at the District Clerk's office.
